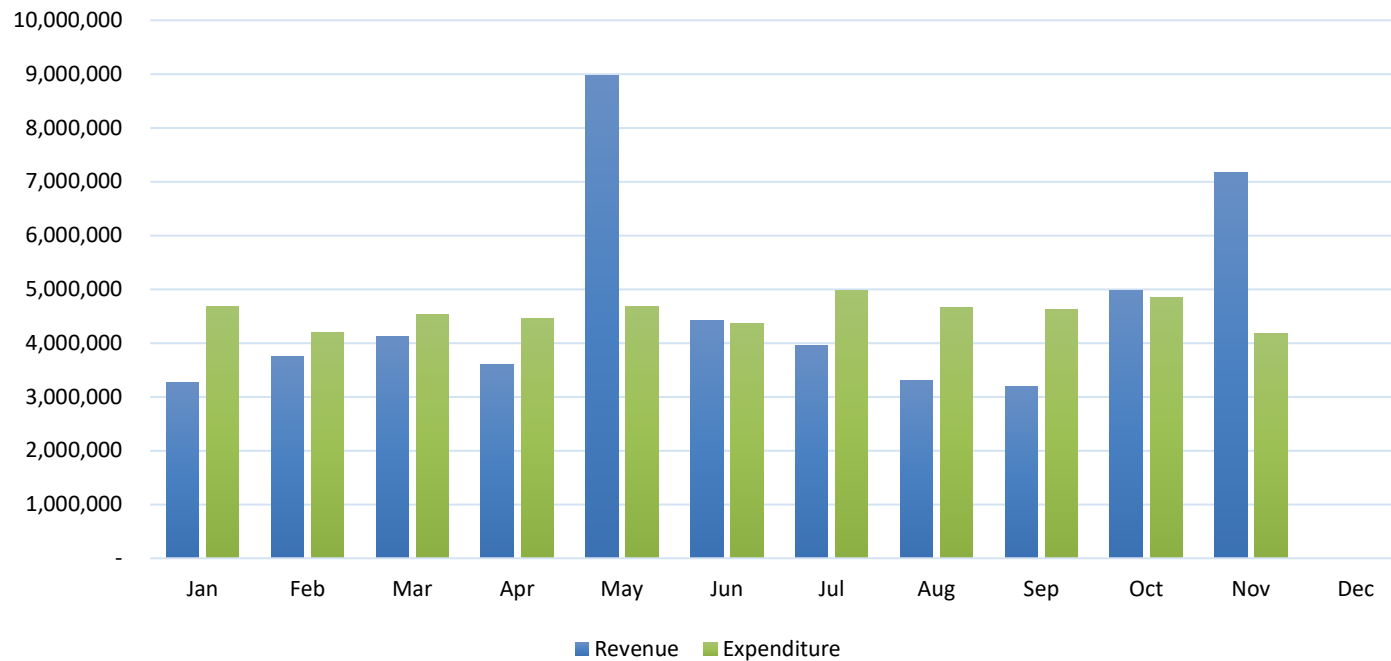

Monthly Revenue/Expenditure Performance General Fund



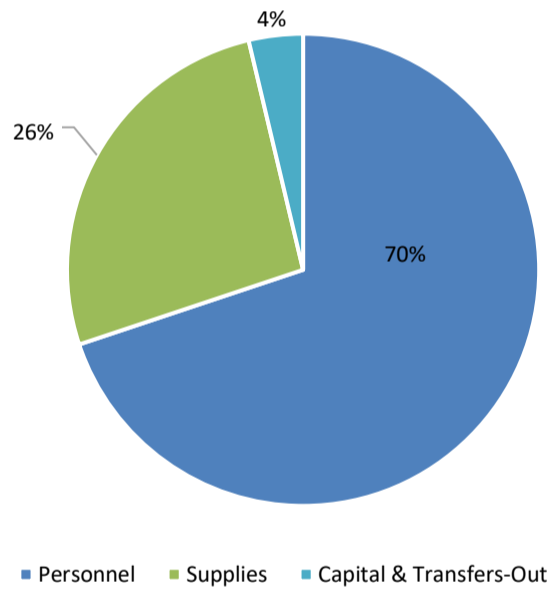


General Fund Expenditures By Department

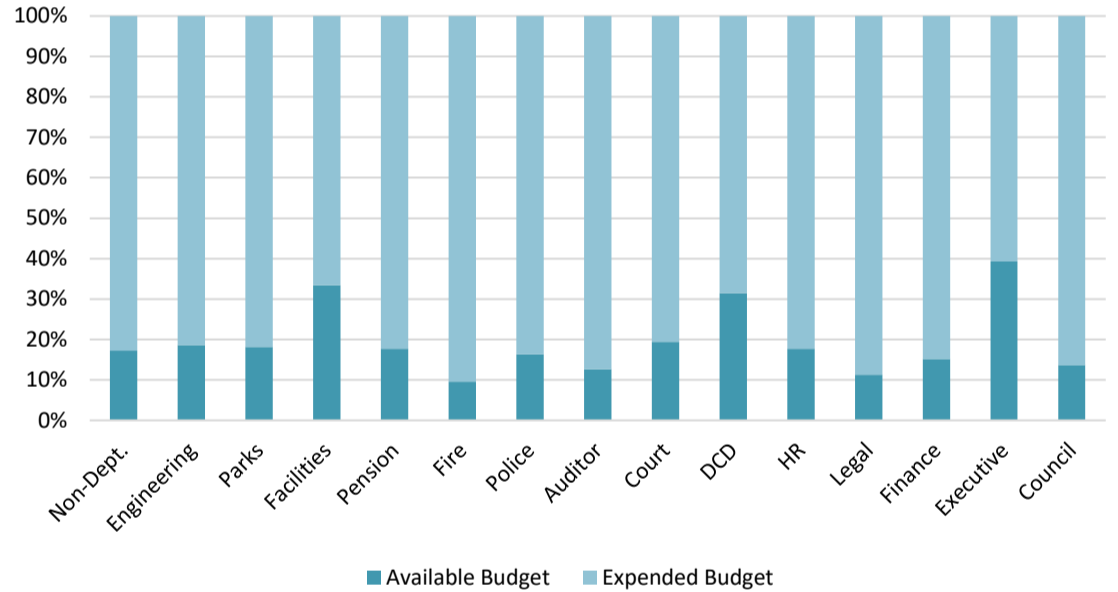

Available vs. Expended





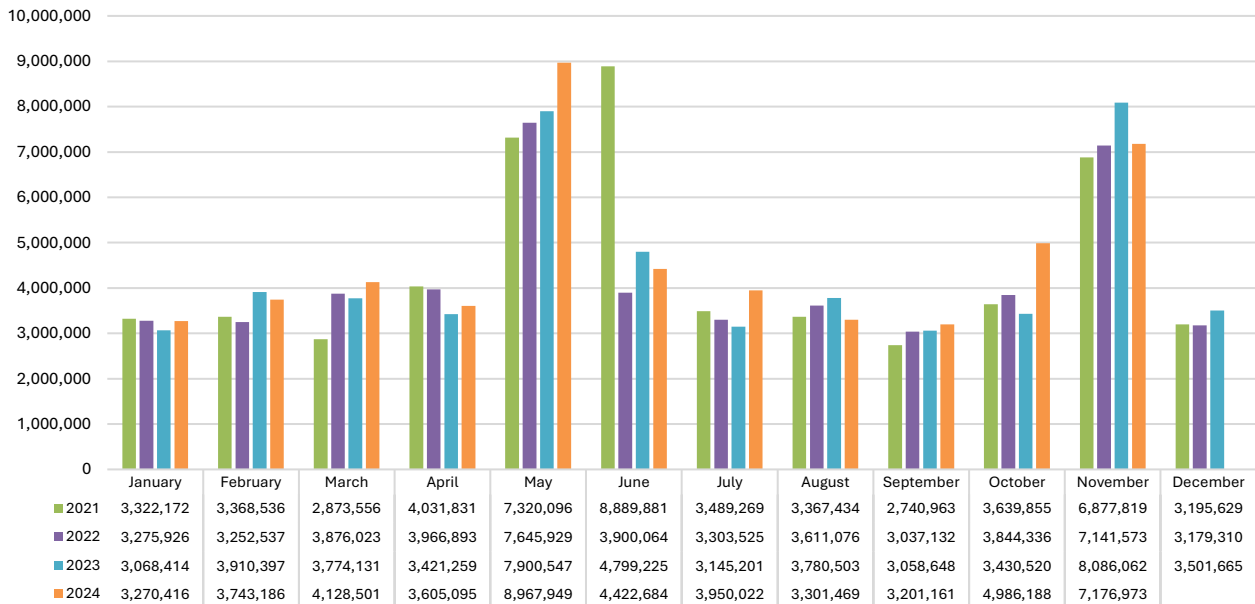

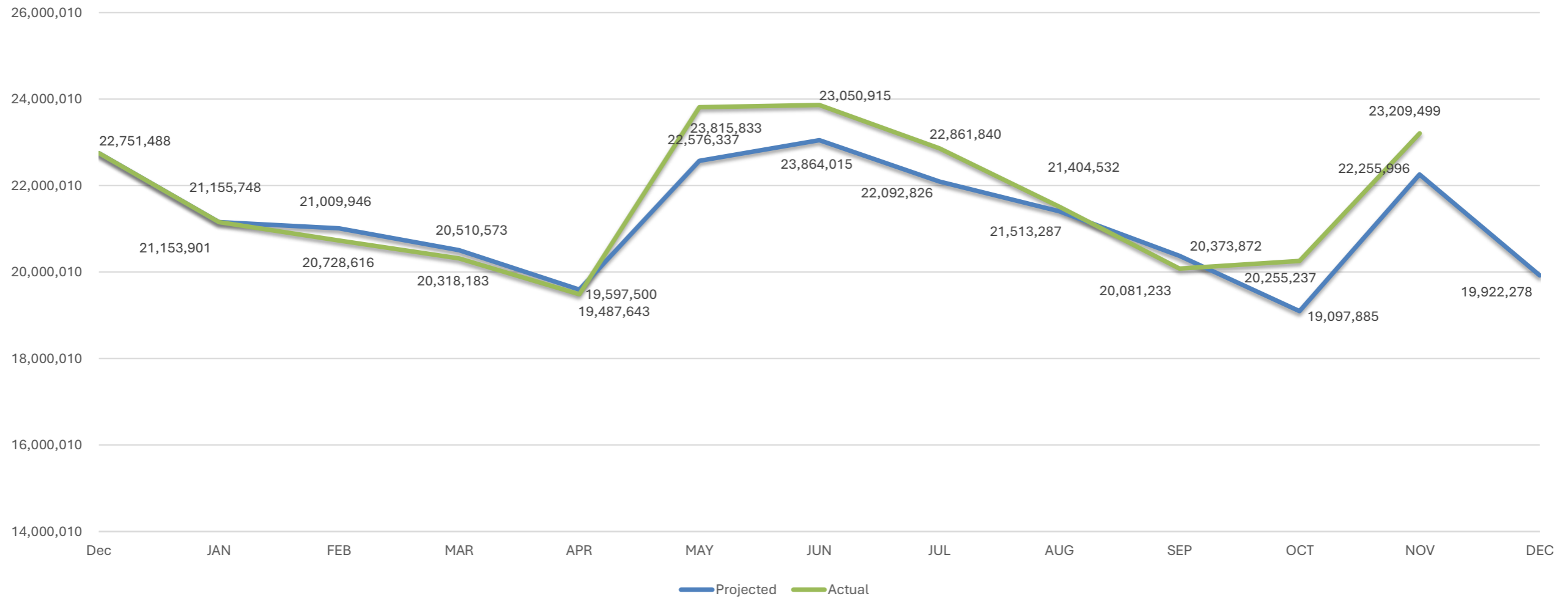
