Funds will be used to acquire a location and build a low-barrier shelter, including a series of pallet shelters (tiny home private units) and a congregate shelter housed in a new Quonset hut or similar building. The shelter will house 30-50 people in the congregate building, 40-60 people in pallet units, and may be able to expand during emergencies. This low-barrier model is designed to stabilize people who are homeless or in other precarious situations, and then provide resources for them to transition into permanent housing.

Funds will be used to acquire 23 new units of affordable housing for low-income families with children in Bremerton. Twenty-three of the units are two-bedroom units at 995 square feet each. A 951-square-foot live-work space will also be provided to residents. This apartment building is centrally located on the region’s main bus corridor and within walking distance of two elementary schools, a grocery store, a Boys and Girls Club location, and a public library.

Funds will be used to address acute, and time-sensitive needs of the Max Hale Apartments, which provides 53 units for people at or below 30% AMI (Area Median Income), including 12 apartments for people with disabilities. These include replacing the roof, replacing the failed cement plaster exterior wall cladding to prevent water intrusion, improving the HVAC system and ventilation to improve indoor air quality, and undertaking significant repairs to the windows and their frames to improve insulation.

Funds will be used for Down Payment Assistance (DPA) and direct administrative costs of the Kitsap County Homeownership program. The program will pair HOME funds with internal and lender-partner funds to provide up to 20% DPA and closing cost assistance to program-qualified, mortgage-ready homebuyers at or below 80% Area Median Income purchasing an eligible home outside the Bremerton city limits in Kitsap County. Individual Pre-Purchase Counseling is required for all participants. All DPA money revolves to future low-income homebuyers in perpetuity.

Funds requested will help construct a new 11,900 square foot food bank and community resource center. The new facility will serve 3,000 additional individuals per year (19,000 total) and offer more fresh produce and healthy food options. The community resource center will provide mental health counseling as well as case management services to help low-income people connect with social services and stabilize financially.		
Housing Kitsap Heritage Apartments – Stair Repair Project Type: Housing (Rental Rehab) Location: Port Orchard Service Area: Kitsap County	56 Units	\$189,205 \$189,205 CDBG
Funds will be used to pay for rehabilitation of the exterior stairs to a 56-unit apartment building for very-low income tenants. The stairs and attached landing are in of need significant structural repair, which will necessitate alternative temporary staircase access for residents. The project will also install new railings and treads to enhance safety and accessibility. Heritage Apartments also received a CDBG grant to paint and repair damage to the exterior of the building in 2015.

Funds will be used to replace the 30+ year-old roof of each of the three two-story buildings of this low and very-low income apartment complex in Kingston. Layered funding of Low-Income Housing Tax Credits and HUD Project Based Voucher assistance ensures affordable rents for tenants.		
HOUSING KITSAP Home Rehabilitation Program Project Type: Housing (Homeownership Rehab) Location: Varies Service Area: Kitsap County (excluding Bremerton)	7 Households	\$225,000 \$125,000 CDBG
Funds will be used for personnel, administration, and construction costs associated with the home rehabilitation program which provides 20-year deferred loans or grants to very-low and extremely low-income homeowners for repairs to address health, safety, and accessibility issues. Housing Kitsap staff performs the home inspections, creates a scope of work, assists homeowners with contractor selection, monitors the progress and signs off project completion and contractor payments.		
KITSAP COMMUNITY RESOURCES (KCR) Business Education Support & Training (BEST) Project Type: Microenterprise Business Assistance Location: Bremerton Service Area: Kitsap County	30 Individuals	\$60,000 \$30,000
Funds will be used for staff, program costs, and direct client support costs of the Business, Education, Support & Training (BEST) Program which increases economic opportunities for low-income individuals who want to start or expand their own micro-enterprise business by providing 8-week training classes offered once per quarter, monthly		

networking events (in English and Spanish), and one-on-one consultations for participants after they graduate. In addition, a 6-week training course will be offered in Spanish four times per year. Micro-enterprise business is a business with five or fewer employees, including the owner. The program is requesting \$120,000 total - \$60,000 from the County and \$60,000 from the City of Bremerton.

Residents will earn below 30% AMI and will be exiting homelessness. One of the nine homes is ADA and 504 accessible. This project has received prior funding from the Capital GRC.

The Program works with pre-approved Kitsap County contractors to perform weatherization measures and minor home repair for homeowner and rental households resulting in 30% reduction in energy usage. The program serves households below 50% Area Median Income with priority given to those with extremely high housing burden, seniors, disabled persons, and families with children under 19 years of age, throughout Kitsap County. The program is requesting \$200,000 total - \$150,000 from the County and \$50,000 from the City of Bremerton.

The building's target population is individuals who are discharged from PCHS's Medical Respite Center across the street and would likely be entering homelessness. Residents will have access to shared laundry facilities and a rooftop deck, and the building's location in downtown Bremerton would give residents access to a host of wrap-around services from PCHS and partner organizations, as well as public transit options. The building will also include 10 units of market-rate housing.

These individuals regularly have trouble finding housing. PCHS aims to cite the housing close enough to Poulsbo to access public transit options and the other amenities and services in the city.

In addition, an adjacent low-barrier shelter will be built to serve tribal members who are homeless or imminently at risk of homelessness. Both projects will be located on a single site near the Suquamish Administrative Center.

The shelter expansion will include a new pet boarding and outdoor areas, as well as a new dining room. The assistance office will provide services focused on establishing pathways to long-term housing and economic stability for residents, including transitional and permanent housing in SVdP's wider Phase I Campus Revitalization Project.

This design aims to provide equitable housing		

opportunities, particularly targeting vulnerable populations such as women transitioning from the WA Corrections Center for Women and those eligible for Washington's Apple Health & Home program. The complex will offer comprehensive support services transitional and permanent supportive housing, which will focus on establishing pathways to long-term housing and economic stability for residents.

The site will feature a playground and ample parking. It is also located directly adjacent to the region's main bus corridor, and within walking distance of Walmart on Highway 303.

The project is designed to serve multi-generational families, with its larger three and four-bedroom units, and 10% of units are reserved for people with disabilities. The site will feature a community center, business center, sport court, and ample parking. It is also located directly adjacent to the region's main bus corridor, and within walking distance of the Walmart on Highway 303.

Funds will be used for staff costs for 9 staff members for the BOOST program. The BOOST program provides low-to-moderate-income women and minority childcare providers with personalized coaching and digital tools to optimize operations and revenue, allowing them to efficiently manage and expand their small businesses, creating local jobs and increasing access to affordable childcare. Specific activities include direct marketing support, family matching support, enrollment automation, electronic Child Profiles that track educational progress, education and curriculum planning and other business support activities. The program is requesting \$384,000 total - \$240,000 from the County and \$144,000 from the City of Bremerton.

Fuller house serves women with substance use disorders and/or mental health issues, and their children. This project currently has CDBG funds for interior renovations.
