- The sponsoring group is required to submit a tournament schedule matrix showing dates, times and fields to be used no-later than 12:00 noon the Tuesday prior to your scheduled event. Failure to do so may result in field maintenance staff not scheduled for part or the entire event.
- **Comply with the recommendations of department staff and game officials concerning the playability of fields.**
- Applicants must provide supervision for the entire event.
- All organizations, groups, and/or individuals utilizing department facilities must leave them in satisfactory condition. Failure to do so will result in additional maintenance costs charged to your organization, group or individuals responsible
- The applicant agrees to exercise the utmost care in the use of facilities and hold the City of Bremerton, its officials and employees harmless from liability resulting from the use of these facilities.
