RE: TIGER Grant Letter of Support: Gorst Transportation Corridor Planning Study

Dear Sir or Madam,

I am writing to support the City of Bremerton's TIGER grant application for corridor transportation planning in the Gorst area of Kitsap County, Washington. Kitsap County is home to over one-third of the region's defense workforce of more than 15,000 employees and 5,000 defense contract workers, with a combined payroll of over \$1.5 billion per year. Traffic in the Gorst area currently far exceeds the capacity of the system during the morning and evening commutes, causing significant travel delays for workers and visitors.

This critical transportation corridor links Mason and Kitsap Counties with I-5 and is at the junction of SR-16 and SR-3. In addition to linking the cities within Kitsap County to Mason and Pierce counties, the Gorst corridor provides access to the many installations of Naval Base Kitsap, home to the 20,000 workers noted above. Closely adjacent to the west, SR-3 serves the South Kitsap Industrial Area (SKIA), one of only eight designated Manufacturing/Industrial Centers in the Central Puget Sound region. This important regional designation is conferred by the Puget Sound Regional Council. SKIA is expected to be home to 10,000 additional jobs within the next 20 years.

This planning effort is strongly supported by the State of Washington as well as local jurisdictions, evidenced by a \$500,000 planning budget provision, funded by the State of Washington to improve the SR-3/SR-304 interchange serving Naval Base Kitsap. Several local municipalities and agencies (Kitsap Transit; City of Port Orchard; City of Bremerton; Port of Bremerton; Kitsap County) and the Washington State Department of Transportation recently collaborated to provide the necessary grant match on a \$454,000 federal study of the Gorst corridor. In total, this partnership provided \$54,000 to ensure the study effort could go forward.

This TIGER planning grant will take the output of the study efforts listed above and complete an Interchange Justification Report, providing the foundational basis for the final NEPA work. I sincerely hope you will give the City of Bremerton your strongest consideration as you review applications for these funds. Thank you.
